

# BLUE LAKE TOWNSHIP RESOLUTION TO ESTABLISH SALARIES 2014

Whereas, pursuant to MCLA 41.95(3) which provides that in a township that does not hold an annual meeting the salary for officers composing the township board shall be determined by the township board, and

Whereas, the board of Blue Lake Township deems it desirable to set the salary of Elected and non-elected positions to ensure that compensation for these positions remains equitable and commensurate with the duties of each position,

Now therefore be it resolved that in Blue Lake Township the Salaries and Compensations starting July 1, 2014 shall be as follows:
